

CANDIDATE SITE SAFETY DECLARATION

In addition to the Mando Solutions Safe Working Directive I understand the following Rules & Expectations have been collated to make sure all candidates working for Mando Solutions' clients are aware of their responsibilities when working on any site, and when operating equipment and machinery of any kind. I understand that these Rules & Expectations form part of the standard agreement between Mando Solutions and their clients to ensure that any risks to Health and Safety are kept to a minimum

I agree to adhere to these requirements as a minimum and acknowledge that this is not an exhaustive list but that I should adopt a common sense approach with any issues when working on site. I agree to:

General Site Safety Rules / Requirements (all candidates to complete)	✓
Adhere to site safety rules/permit restrictions for ANY site I work on as laid down by the Site Supervisor	
Actively attend any inductions required PRIOR to commencing work	
Make sure I have the correct PPE at ALL times	
REPORT to the Site Supervisor any concerns in a professional manner, and if I do not feel this has been addressed appropriately report to Mando Solutions	
Behave responsibly and professionally at ALL times	
NEVER enter restricted areas without authorisation	
ONLY operate equipment I am qualified and skilled to operate	
ALWAYS inspect equipment before commencing work to ensure it is safe to operate and in good working order	
Highlight any concerns or any defects on any equipment to the Site Supervisor prior to commencing work and if I do not feel this has been addressed appropriately report to Mando Solutions	
ALWAYS operate equipment in accordance with manufacturer's instructions	
NEVER misuse equipment	
Take care of myself and others by reporting any problems or hazards IMMEDIATELY as soon as it is safe to do so to the Site Supervisor, and if I do not feel this has been addressed appropriately to Mando Solutions	
ENSURE I have seen and understood any risk assessments and method statements for planned works	
Plant Operative Rules / Requirements (complete this section if you will be working on plant equipment)	✓
ALWAYS operate machines in accordance with manufacturer's instructions	

ALWAYS inspect my machine before commencing work to ensure it is safe to operate and in good working order – including any lubrication required.	
Highlight any concerns or any defects on any machine to the Site Supervisor and Mando Solutions PRIOR to commencing work.	
ALWAYS make sure ground conditions are adequate for the machine and loads required	
Maintain any machine I work on is in good working order, including greasing and report any defects IMMEDIATELY	
Keep machine clean and tidy at ALL times. Respect that the machine belongs to the clients of Mando Solutions	
Remain VIGILANT during operation of machinery to ensure risk of accident / injury / damage is avoided	
Make sure I update any machine logs / tick lists / log books as required	
ALWAYS make sure ground conditions are adequate for the machine and loads required	
NEVER risk any manoeuvre / activity if it is not safe	
NEVER risk any manoeuvre / activity that you are not competent to do	
ALWAYS make sure I have permission to operate equipment / dig where required	
ENSURE I have a banksman in attendance when reversing	
Physically CHECK that the quick hitch and safety pin is secure and locked before use.	
NEVER lift over the heads of others - keep them at a safe distance	
ENSURE that any machinery is parked safely and isolated before vacating the machine.	
Mounting/Dismounting:	
ENSURE that any machinery is parked safely and isolated before vacating the machine.	
Make sure ALL steps and handholds are clean and in good order	
Follow ALL required standards for safe mounting/dismounting of machinery	
Working Time Directive (all candidates to complete)	
I will take at least 11 hours break between one shift ending and another shift starting. Anything less may be considered a double shift. I will notify Mando Solutions of any instance where I have worked a 'double shift' WITHOUT fail	✓
A period of break or rest WILL be taken at least once every 6 hours by legislative and collective agreement	
A rest period of at LEAST 24 hours uninterrupted once a week, but on agreement that this may be occasionally justifiable to waive for technical, organisational or work reasons. I must notify Mando Solutions of any occasion.
